The amount of financial support provided and the age divisions covered varies by District. There is no guarantee that financial support will be provided to golfers who travel outside of their home District. Please check with the District Chair for details.

**Age Eligibility Information:**

Golfers must be enrolled in high school or must be a 2026 high school graduate to be eligible. Any golfer who has attended college is no longer considered a "junior golfer" and is not eligible to participate.
